CQC Report hails 'Good' surgical and critical care

Surgical and Critical Care Services at RJAH have been rated as 'Good' overall by the Care Quality Commission (CQC).

The CQC rates services by classifying them as Outstanding, Good, Requires Improvement or Inadequate against five criteria to determine whether services are safe, effective, caring, responsive and well-led.

Inspectors took an in-depth look at the Trust's surgical and critical care services specifically, during the inspection in May of this year.

The report shines a specific spotlight on the care that was observed, noting that people were treated with kindness and compassion, and that staff protected patients' privacy and dignity.

Representing People

When Parliament created NHS foundation trusts, it provided them with independence from central government and a governance structure that ensured participation from within the local communities they serve.

NHS foundation trust governors are the direct representatives of local interests within foundation trusts. Governors do not undertake operational management of NHS foundation trusts; rather they challenge the board of directors and collectively hold them to account for the trust's performance. It is also the governors' responsibility to represent their members' interests, particularly in relation to the strategic direction of the trust.

Legislation provides governors with statutory responsibilities to help deliver these key objectives. The legislation is the National Health Service Act 2006 and the Health and Social Care Act 2012. Please note that meetings of the Council of Governors are open to members of the public. The public are asked to notify the Trust of any matters they wish to raise in advance, as this will allow the Trust to be able to respond fully and will assist in the time management of the meeting.

Charity update

Friends continue to make a positive impact at RJAH

The League of Friends have continued to demonstrate their commitment to enhancing patient experience and supporting staff at RJAH. Their recent projects highlight the wide-ranging impact of their work across the Trust.

A new mural has been installed in the X-Ray Department, designed to create a bright and welcoming environment for paediatric patients. The project was made possible thanks to funding from the charity, with the design brought to life by Shropshire Design and Print Solutions.

In addition, the League of Friends have funded three new ultrasound machines for the Anaesthetics Department. This £80,000 investment provides clinicians with access to the latest technology, helping to improve both the precision and efficiency of patient care.

Their support is not limited to financial contributions. Volunteer involvement continues to make a real difference across the hospital, including on the Midlands Centre for Spinal Injuries, where Melvin has been providing one to one digital assistance to patients, helping them become more confident with assistive technology. He is working closely with Jess Potts, Assistive Technologist from Aspire – a charity that supports people from injury to independence.



News from the Trust

Pre-Op screening pathway set to reduce cancellations and improve recovery

A new dedicated early health screening pathway has been introduced at RJAH to help adult patients prepare for surgery, reduce cancellations and improve recovery times.

The initiative, led by the Pre-Operative Assessment team, identifies and addresses potential health risks at the earliest stage of a patient's surgical journey. Patients listed for inpatient surgery at their outpatient appointment are invited to a health screening clinic, where their general health and fitness for surgery are assessed.

Using digital screening via iPads, staff can quickly capture key information before nurses and healthcare assistants carry out tests such as blood pressure, BMI, iron levels, and MRSA screening. Results are reviewed by the Optimisation Nurse, who can provide tailored advice on areas such as smoking cessation, nutrition or fitness.

By introducing screening earlier, RJAH can intervene sooner, reducing repeat appointments, theatre disruptions and improving overall patient outcomes.



Headley Court charity relocates to RJAH

The Headley Court Charity, who seek to support the needs of Armed Forces veterans, has formally relocated to RJAH.

Headley Court was previously a military rehabilitation centre in Surrey before closing in 2018, when services moved to Stanford Hall near Loughborough. Since then, the charity has focused on funding projects that honour the legacy of Headley Court, including awarding a £6 million grant to RJAH in 2020 to create the UK's first dedicated veterans' orthopaedic centre.

The centre opened in late 2021, and the charity's move to RJAH further strengthens this important partnership in veterans' healthcare.

Patients the winners as hospital programme smashes milestone

Back in June, clinicians were celebrating after discharging their 1,000th and 1,001st patients on the same day as receiving a new knee or hip.

Phil Holdcroft, 45, from Bulkeley, near Chester, was the landmark patient when he received a new hip from Professor Geraint Thomas. The following day Anne Long, 72, from Crewe, became the 1,001st patient to go home on the same day as surgery after receiving a new knee from Mr Niall Graham.

Both Phil and Anne were seen under the care of the Enhanced Recovery Programme, launched back in April 2023, which is a modern, surgically led and evidence-based approach that helps patients undergoing surgery get back to health as soon as possible following their operation.

It ensures that a patient's health is optimised prior to surgery, improved pain management is introduced during their hospital stay, and that post-operative mobilisation is achieved earlier.



RJAH hailed as high performer in major national survey

RJAH has again been singled out as one of the very best in the country following the results of a major national survey.

Patient feedback has seen the organisation named as one of just eight providers producing results "much better than expected" in the annual Adult Inpatient Survey.

The survey is produced by the CQC, who monitor, regulate and inspect health and social care services in England. It is based on feedback from more than 63,500 people who had a spell as a hospital inpatient during November 2024. More than 1,200 RJAH patients were invited to take part in the survey, and the response rate of 70% was the best in the country and well above the national average of 41%.

RJAH has been named by the CQC as one of eight organisations placed in the top band of Trusts delivering results that are considered "much better than expected", with patient experience that is substantially better than elsewhere.

Detailed analysis shows that its hospital wards and rooms are rated the cleanest for the fifth year in a row.

The survey also included questions on whether patients, as well as their family members and carers, had been involved by staff in decisions about their care and treatment – and RJAH scored highest this year across this area for the second straight year.
