Veteran healthcare gets £6million boost

The UK's first dedicated orthopaedic centre for Armed Forces veterans is to be built at RJAH – thanks to a remarkable £6 million charitable grant.

The hospital had initially launched a ± 1.5 million appeal in October 2018 to build a more modest outpatient facility for veterans, but is now set to realise a grander vision thanks to the support of the Headley Court Charity.

Headley Court was the leading medical rehabilitation base for members of the Armed Forces before the transfer of those services to a new facility at Stanford Hall. Following the move, Trustees of the Headley Court Charity, have been looking for worthy causes in keeping with their ethos and aims to support in the form of charitable grants from their reserves.

They identified the Veterans Orthopaedic Centre at RJAH, which aims to treat service personnel and veteran patients in a bespoke, military environment, which feels familiar to them, while addressing their specific needs – physically, mentally and emotionally.

Air Vice Marshal Anthony J. Stables, Chairman of the Headley Court Charity, said: "Trustees are delighted to be able to support the build of the country's first dedicated Veterans' Orthopaedic Centre. This centre will expand on the fantastic work already provided by the Veterans' Orthopaedic Service at RJAH."

Initially started in 2014, the Veterans' Orthopaedic Service was started by Lieutenant Colonel Carl Meyer, a serving Army Officer who is also a Consultant Orthopaedic Surgeon at RJAH, and treats patients with arthritic lower limb conditions.

Representing People

When Parliament created NHS foundation trusts, it provided them with independence from central government and a governance structure that ensured participation from within the local communities they serve.

NHS foundation trust governors are the direct representatives of local interests within foundation trusts. Governors do not undertake operational management of NHS foundation trusts; rather they challenge the board of directors and collectively hold them to account for the trust's performance. It is also the governors' responsibility to represent their members' interests, particularly in relation to the strategic direction of the trust.

Legislation provides governors with statutory responsibilities to help deliver these key objectives. The legislation is the National Health Service Act 2006 and the Health and Social Care Act 2012. Please note that meetings of the Council of Governors are open to members of the public. The public are asked to notify the Trust of any matters they wish to raise in advance, as this will allow the Trust to be able to respond fully and will assist in the time management of the meeting. Replica badge to celebrate Nursing & Physio training

A replica of a special badge, devised by Dame Agnes Hunt, one of the hospital's founders, and awarded to all students completing a five year combined Nursing and Physiotherapy training programme was unveiled to staff and retired Nurses and Physiotherapists.

The badge was awarded from 1944 to 1969, after which Dame Agnes' training school merged with North Staffs Royal Infirmary and a new pin was created.

The idea to create and display the replica badge was the brainchild of retired Physiotherapist, Gill Cripps.

Gill, as well as her friends and former colleagues, who were members of the Old Oswestrians' Physiotherapists Association have organised and funded the badge, with support from the hospital's League of Friends.

Pet therapy brings joy to RJAH patients



A whole new breed of hospital visitor is brightening the lives of patients at RJAH with the introduction of therapy dogs.

The Therapy Dogs Nationwide charity has provided doggy guests to visit patients, including Lola the Chihuahua and Katie the Pug, who are temperament assessed therapy dogs.

They will provide a much needed boost for patients, particularly those who are in hospital for a prolonged period of time – such as patients on the Midland Centre for Spinal Injuries (MCSI).

Kate Betts, Rehabilitation Technician on MCSI, was the driving force behind the introduction of the four-legged friend as therapy for the patients and has been supported by the League of Friends.

Violet Jenkins, who has been a patient on MCSI for more than three months, said: "It's absolutely marvellous having Lola come in to see us. She lifts everyone's spirits no end. It's not easy being away from home for a long stretch of time, so for most of us, Lola feels like a bit of home is being brought into hospital for us. That's really special."

Due to the current covid-19 pandemic, all therapy dog visits have been suspended for the time-being, after discussions with the Infection Control and Prevention Lead at RJAH and the Therapy Dogs Owner.

RJAH female surgeons flying the flag for women in surgery

Female Orthopaedic Surgeons at RJAH are proudly wearing their new personalised theatre scrub caps – all in a bid to promote women in surgery.

The team at The Robert Jones and Agnes Hunt Orthopaedic Hospital have had scrub caps specially produced from company Scrub'd Up to make female orthopaedic surgeons, and in particular speciality trainees, more identifiable when in Theatres.

Approximately 12% of surgeons across the UK are female, and in the sub-speciality of trauma and orthopaedics, this figure drops to even less at 6%.

The idea came from Miss Gillian Cribb, Consultant Orthopaedic and Oncological Surgeon and Clinical Lead for the Tumour Unit, who said: "Being in such a minority group, it's often assumed that female orthopaedic surgeons are other members of the surgical team so these caps really help distinguish us as surgeons when in theatres."

Standard of care at RJAH gets ringing endorsement from staff

Staff at RJAH have given a ringing endorsement to the care provided at their own organisation – with table-topping results in the NHS Staff Survey 2019.

A total of 94.8% of RJAH staff completing the survey said they would be happy with the standard of care provided by their organisation if a friend or relative needed treatment there.

RJAH has also received another endorsement from its staff as an employer, with 77% recommending it as a place to work – a score that ranks it among the top 10 Trusts in the country.

Almost 62% of staff at RJAH completed the survey in 2019 – the highest figure since response rates were first recorded in 2004 and an increase of almost 20% from just 12 months ago.

The NHS Staff Survey is an annual exercise, which gives the largest and most detailed insight into the morale of the NHS workforce as a whole.

New veterans' orthopaedic centre will 'offer patients an extraordinary lifeline'

Former Welsh Guardsman – Mark Emptage – was at the lowest point in his life, before he was able to refer himself to the dedicated Veterans' Orthopaedic Service at RJAH.

Mark Emptage, from Llandudno, has had both his right and left knees replaced, in 2018 and 2019 respectively, by Lieutenant Colonel Carl Meyer, Consultant Orthopaedic Surgeon and Serving Officer in the British Army.

Following a fall whilst in service, he suffered with excruciating pain ever since leaving the service back in the late 1970s. Over the years the pain worsened and he eventually developed arthritis.

Mr Emptage had always led an active lifestyle through his work and hobbies; however in 2017, as his physical health deteriorated, he was forced to give up work and his sporting activities.

He said: "Giving up work and the things I loved doing the most was hard. Cycling was not only a hobby, it was what I did when I needed to clear my head when things were tough, and without that, I found myself in a downward spiral.

"It was the hardest time of my life, I couldn't do the simplest of tasks that we all take for granted like putting on my own socks, and it felt as though nobody was able to help me but then I was made aware of the Veterans' Orthopaedic Service at RJAH.

"The care I received at RJAH was absolutely phenomenal. The Veterans' Orthopaedic Service gave me my life back, after being at my lowest. I can do all the things I didn't think I'd be able to do for a long time again.

"Just five months after my having my second knee done, I was able to take part in the Battlefield Bike Ride – a 350 mile ride around Normandy; I could never have even contemplated that before my operations."
