RJAH planning for growth with hi-tech Theatre expansion

A state-of-the-art extension to the Theatre building is under way – in a move that will help cut waiting lists.

The development will initially see the addition of one new Theatre, giving the capacity to carry out an additional 1,200 surgical procedures a year.

The current phase of the scheme is costing £10.3 million – with £5.3 million of that coming from the Trust's own capital funds and £5 million from a successful bid to the Department of Health and Social Care's Targeted Investment Fund – which was money made available to support schemes that promote recovery from the pandemic.

Stacey Keegan, Chief Executive, said: *"We're excited to have already secured the funding and begun work on the first phase of this project.*

"In the long term this is about growth, but we are very focussed on also getting down our waiting lists and giving all our patients the experience they expect and deserve.

"Before covid, our activity levels were around 10,700 procedures a year, and this new, additional Theatre will help us get back to that and beyond."

RJAH also has exciting plans to build three further new Theatres over the next three years, as well as refurbishing four existing ones. The development plans are evolving in conjunction with co-ordinated recruitment and retention activity to ensure the hospital has the staff and the skills it needs to make the most of the new facilities.



Representing People

When Parliament created NHS foundation trusts, it provided them with independence from central government and a governance structure that ensured participation from within the local communities they serve.

NHS foundation trust governors are the direct representatives of local interests within foundation trusts. Governors do not undertake operational management of NHS foundation trusts; rather they challenge the board of directors and collectively hold them to account for the trust's performance. It is also the governors' responsibility to represent their members' interests, particularly in relation to the strategic direction of the trust.

Legislation provides governors with statutory responsibilities to help deliver these key objectives. The legislation is the National Health Service Act 2006 and the Health and Social Care Act 2012. Please note that meetings of the Council of Governors are open to members of the public. The public are asked to notify the Trust of any matters they wish to raise in advance, as this will allow the Trust to be able to respond fully and will assist in the time management of the meeting. Reservists at training camp as hospital celebrates Armed Forces

Three Armed Forces reservists from RJAH swapped their NHS uniform for camouflage gear as they took part in a fortnight-long training exercise.

The trio were Consultant Orthopaedic Surgeon, Lieutenant Colonel Carl Meyer; nurse and Enhanced Recovery Lead, Warrant Officer Rebecca Warren; and Physiotherapist, Captain Helen Weavers – and the exercise saw them away as the hospital and the NHS marked Armed Forces Week, which ran from 19 June to 24 June.

Hospital Friends support Theatres with £50,000 investment

The League of Friends at RJAH have invested £50,000 in two new portable ultrasound scanners, which will be used by Consultant Anaesthetists performing nerve blocks for pain relief and IV access.

Dr John John, Consultant Anaesthetist at RJAH, said: "Portable ultrasound scanners are probably the most significant advancement in anaesthesia in the last decade.

"We are grateful and fortunate to have access to a very supporting League of Friends that readily fund these initiatives as they have such a direct and immediate impact on patient care."

Veterans' celebratory tea party for the King Charles III Coronation

Military veterans had a right Royal time as they enjoyed a celebratory tea party at RJAH to mark the coronation of King Charles III.



The tea party was held at the Veterans Hub inside the Veterans' Orthopaedic Centre.

Veterans plus their relatives attended the gathering from all over Shropshire, and surrounding areas. They were treated to tea and cake, with a special quiz and a tour of the impressive simulation lab inside the centre being the crowning glory of the event.

Susan Heer, a volunteer at RJAH for almost 15 years and now a full-time veterans' volunteer, was overjoyed to see her parents enjoying the celebration to commemorate the King. Susan was raised in a Military environment – her father served 22 years in the Royal Navy, and her grandfather served in the Royal Air Force.

Susan said: "I was delighted my parents were able to attend the tea party. My Dad is now a carer for Mum, and they both made the journey from the Wirral. The Hub is very important for veterans, like my dad, to socialise and avoid isolation."

The Duchess of Edinburgh officially opens UK's first dedicated veterans' orthopaedic centre

The UK's first dedicated Veterans' Orthopaedic Centre at RJAH has officially been opened by Her Royal Highness The Duchess of Edinburgh.



The Duchess was at RJAH for an official visit in April, that saw her unveil a plaque marking the official opening of the pioneering Headley Court Veterans' Orthopaedic Centre.

The innovative centre was built by local contractor Pave Aways onsite following a £6 million donation from the Headley Court Charity.

Lieutenant Colonel Carl Meyer, Consultant Orthopaedic Surgeon,

launched the Veterans' Orthopaedic Service back in 2014.

He said: "The official opening of the Headley Court Veterans' Orthopaedic Centre is a day I have long dreamt about, even before our fundraising appeal launched in October 2018.

"For a number of years, we have talked about veterans being seen in an environment that brings comfort to them and by clinical teams that have an understanding of military personnel and their unique needs. This is now reality, which marks the beginning of a new era of bespoke care for our veteran patients and members of the Armed Forces."

Stacey Keegan, Chief Executive, said: "We were able to take Her Royal Highness around the state-of-the-art building and show the impact these facilities are having on our patients.

"She also met with staff from across the Trust. It was a great day that everyone enjoyed, and we would like to thank The Duchess for taking the time to visit."
